Sever Air Cargo Capacity Crunch due to COVID -19






Global capacity: - 22.7%








Mexico's Automotive Industry – TODAY.




AUTOMOTIVE SECTION ANNUAL PERCENT VARIATION



UNITED STATES-MEXICO-CANADA AGREEMENT (USMCA).



MEXICO

USMCA

WILL HAVE A PROFOUND IMPACT ON THE AUTO INDUSTRY; THE AGREEMENT CALLS FOR AN INTEGRATED SUPPLY CHAIN, WITH INCENTIVES TO USE NORTH AMERICAN PARTS FOR CARS.



USMCA - What has changed?

- Instead of the **62.5 percent North American content hurdle in NAFTA**, the USMCA sets forth a Regional Value
 Content (RVC), now of 75%, threshold for vehicles and three
 categories of automotive parts: core, principal, and
 complementary.
- There is a new RVC for North American steel and aluminum content and a new labor value content (LVC) rule that states that 40 percent of a passenger vehicle and 45 percent of a pickup or cargo vehicle must be made by hourly workers who earn a wage of USD 16/hour or more. Automakers can earn up to 10 percent credit toward the LVC from R&D and information technology work done in the region where the production takes place, and a 5 percent credit toward the LVC for assembling the vehicle in a high-wage region in North America.
